



### **Alliance for Water Efficiency**

Alliance for Water Efficiency (A4WE) is a stakeholder-based 501(c)(3) non-profit organization dedicated to the efficient and sustainable use of water. The Alliance serves as a North American advocate for water efficient products and programs, and provides information and assistance on water conservation efforts. The Alliance has embarked on several key tasks to support and enhance water conservation efforts, providing benefit to water utilities, water conservation professionals, planners, regulators, and consumers.

### **American Water Works Association**

American Water Works Association (AWWA), established in 1881, is the largest nonprofit, scientific and educational association dedicated to managing and treating water, the world's most important resource. With approximately 50,000 members, AWWA provides solutions to improve public health, protect the environment, strengthen the economy and enhance our quality of life.

### **Association of California Water Agencies**

The Association of California Water Agencies (ACWA) is the largest statewide coalition of public water agencies in the country. Its 430 public agency members collectively are responsible for 90% of the water delivered to cities, farms and businesses in California. ACWA's mission is to assist its members in promoting the development, management and reasonable beneficial use of good quality water at the lowest practical cost in an environmentally balanced manner.

### **National Association of Water Companies**

National Association of Water Companies (NAWC) is the voice of the private water industry. Founded in 1895 by a handful of small water companies, it now has members located throughout the nation and ranging in size from large companies owning, operating or partnering with hundreds of utilities in multiple states to individual utilities serving a few hundred customers. NAWC engages with others looking for new solutions to water-related challenges, including aging water infrastructure, limited water supply, and budget deficits that are preventing much-needed investment in the people, technology and facilities required to help ensure reliable water and wastewater services across the country.

### **National Water Resources Association**

National Water Resources Association (NWRA) represents the interests of 14 states to advocate federal policies, legislation, and regulations promoting protection, management, development, and beneficial use of water resources. NWRA supports development of reasonable and cost-effective local water conservation practices to supplement prudent water supply planning and development for future needs.



## **U.S. Water Alliance**

The U.S. Water Alliance was established in 2008 to break down the “silos” and provide sector-wide leadership for building a national platform for holistic water policy. The Alliance is led by a highly diverse 35 member Board of Directors steeped in experience and leadership and includes representatives from public and private water and wastewater organizations and utilities, businesses, state water and energy regulators, conservation, environmental and agricultural organizations, and academia from all around the country. The Alliance is committed to uniting people and policy for water sustainability in a changing climate. The Alliance emphasizes the importance and value of each aspect of the water cycle and promotes more integrated, sustainable management of water and watersheds.

## **Western Coalition of Arid States**

Western Coalition of Arid States (WESTCAS) is a coalition of approximately 75 water and wastewater districts, cities, towns, and professional organizations focused on water quality and water quantity issues in the states of Arizona, California, Colorado, Nevada, New Mexico, and Texas. Its mission is to work with Federal, State, and Regional water quality and quantity agencies to promote scientifically-sound laws, regulations, appropriations, and policies that protect public health and the environment in the arid West.

## **Western Urban Water Coalition**

The Western Urban Water Coalition (WUWC) is a coalition of 16 water suppliers representing the states of Arizona, California, Colorado, Nevada and Washington and serving more than 35 million customers in the West's largest metropolitan areas. Leaders of several western U.S. municipal water suppliers created WUWC in 1992 to address the West's unique water issues. WUWC is dedicated to new and creative approaches to meet future water demands in the West.
