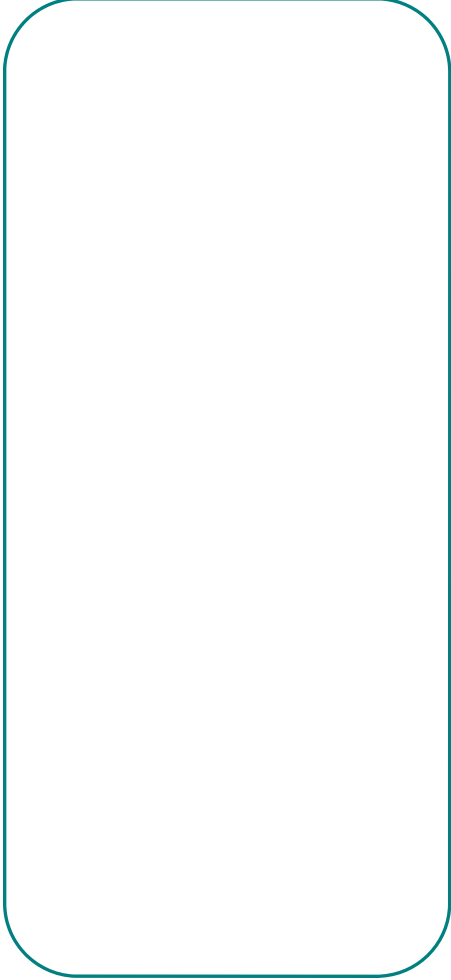
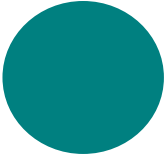
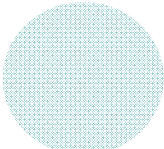

Who is WESTCAS?

Protecting the Area's Water and Environment

The Arid West has a unique ecosystem. Many months have no rain, and annual precipitation often is less than 12 inches. Consequently, it is essential to protect both the quantity and quality of water supplies. To this end, in 1992 the area's water and wastewater providers joined together to share their talents and resources, assuming the name Western Coalition of Arid States or WESTCAS. A grassroots organization, WESTCAS is dedicated to encouraging the development of water programs and regulations which assure adequate supplies of high quality water for those living in the arid regions while protecting the environment.

What does WESTCAS offer?

WESTCAS provides members with a powerful presence in Washington, D.C. and in regional and state regulatory and legislative decision-making; an effective vehicle for information exchange through meetings and publications; the opportunity to help draft federal, regional, state, and local legislation and regulations about water quality and supply.

Who should belong to WESTCAS?

Water and wastewater service providers, including cities and towns, water and irrigation districts, wastewater agencies, Native American nations, and others concerned with management of issues related to water and wastewater supply, such as attorneys, engineering firms, and consulting firms.

The theme of the conference is "Sustainability and Stewardship." The conference will cover key considerations to meet water resource needs in the arid west, both quality and quantity, while honoring compact commitments to down stream water users and meeting endangered species requirements. As the host state, the focus will be on New Mexico's solutions including conversion from ground to surface water for M&I, as well as new sources from reuse of reclaimed and desalination of brackish water. Can the new sources be delivered at a reasonable cost, both economic and environmental, and without exorbitant use of energy---and will they be sustainable over the long term? These same challenges face all of the arid western states and the solutions will come from the experience and insight of WESTCAS members.

San Juan-Chama Drinking Water Project Water Treatment Plant Tour

The Albuquerque-Bernalillo County Water Utility Authority is pleased to invite WESTCAS conference attendees to tour the San Juan-Chama Drinking Water Project Water Treatment Plant. The plant will supply up to 90% of the drinking water for the 520,000 people in the metropolitan area. The tour will look at the \$160 million Water Treatment Plant which can treat about 90 million gallons per day and includes:

From near-river pre-sedimentation ponds, the water is pumped to the main processing area. A coagulant is mixed with the water to bind with sediments and cause them to settle out. Water then flows to ozone contactors, where ozone is added to oxidize any organics and kill bacteria. Remaining turbidity is filtered out using granular activated carbon, which also absorbs any remaining organic material. Finished water storage tanks hold the water before it is treated with fluoride and chlorine and pumped into the distribution system for delivery to homes and businesses.
