"In 50 years, every street in London will be buried under nine feet of manure."



CONGRESSIONAL AGENDA

- FY 2018 **budget**
- Pass tax reform by the end of 2017
- Fix **health insurance** issues
- Another disaster spending bill
- Continue funding the federal government (Dec. 8th)
- Increase the debt ceiling (Dec. 8th)

There are just 25 legislative days left.



FY 2018 FUNDING

- In September, Congress passed a short-term funding bill until December 8.
- The House has passed all of its appropriations bills.
- The Senate has only passed a handful out of committee.



FY 2018 FUNDING

- Senate Republicans passed a \$4 trillion budget by a 51-49 vote.
- Includes reconciliation.
- House will vote this week.

Focus on Corps projects and implementation of 2014 and 2016 WRDA policies.



NON-WRDA WATER INFRASTRUCTURE?

Sen. Jeff Flake announced plans for a Western water infrastructure and drought resilience bill

Previous bill included:

- Bureau of Reclamation Transparency Act
- Water Supply Permitting Act
- Bureau of Reclamation Project Streamlining Act
- Water Rights Protection Act



HOWEVER...

WRDA may be the only infrastructure legislative vehicle moving.



EPA'S WATER TRANSFER RULE

WHAT THE RULE DOES

Excludes water transfers, into which no outside pollutants have been introduced, from the NPDES permit requirements.



CURRENT STATUS

Rule was challenged in court, NWRA submitted an amicus brief in support of rule.

January 18, 2017 the Second Circuit Court of Appeals found that an NPDES permit is not required, affirming EPA's Water Transfer Rule and NWRA's view.

September 15, 2017 New York, Connecticut, Delaware, Illinois, Maine, Michigan, Washington and the Canadian province of Manitoba filed a petition to the Supreme Court arguing that the Rule was unlawful and violated the CWA's mission to keep pollution out of waterways.



POTENTIAL CONGRESSIONAL ACTION

Western water users and NWRA are working with several Congressional members on codifying the Water Transfer Rule.



WATERS OF THE UNITED STATES

SUPREME COURT ACTION

October 11, 2017 - Supreme Court argument on jurisdiction over "Waters of the United States" rule.

 The question before the Court is whether the case should be heard in district courts or courts of appeals.



THE EPA AND THE ARMY CORPS OF ENGINEERS FORMALLY PROPOSED THE WITHDRAWAL OF THE "WATERS OF THE U.S." RULE.

Step 1 recodification of 2008 guidance governing the jurisdiction of the Clean Water Act as an interim measure to provide certainty for those affected by the rule.

Step 2 reworking of the rule to actually define "Waters of the United States." NWRA will submit recommendations by November 28, 2017.






